- EMPLOYEES WITH 30 YEARS OF SERVICE TO THE COUNTY AT RETIREMENT (55) ARE ELIGIBLE FOR A 50% PAID COVERAGE

OTHER MODIFICATIONS:

- RETIREE HEALTH CARE COVERAGE WILL BE LIMITED TO RETIREE ONLY
- NO PAYMENTS WILL BE MADE IN-LIEU OF HEALTH CARE COVERAGE FOR RETIREES
- ELIGIBILITY FOR RETIREE HEALTH BENEFITS WILL BE LIMITED TO THOSE RETIREES THAT DO NOT HAVE COVERAGE AVAILABLE THROUGH ANOTHER PLAN EITHER THROUGH THE RETIREE OR SPOUSE. IF NO OTHER PLAN IS AVAILABLE THEN THE COUNTY WILL PAY

He informed the Board that he is waiting for an opinion from the Board's attorney as to what language should be used to ensure the benefits awarded to the appointed and elected in the October 31, 2000 agreement and any subsequent agreements follow the intent of the agreement and state law. He recommended HS-028-04 and HS-029-04 be defeated and language be put in place which addresses appointed and elected health according to the law.
